I declare that:

A. No person who will be involved, in any capacity, in transporting animals under this authorisation has any conviction, Home Office Simple Caution record, current ban or disqualification order pertaining to any infringement of European Community legislation and/or United Kingdom legislation on the protection of animals in the three years preceding the date of this application.

B. I am responsible for the validity of all the information that I have given on this form, including information about other people

C. As the person completing this form I have gained consent of the individual(s) named on this form and they are aware of how their personal data will be processed and for what purpose(s)

D. If I give information that is false or misleading and I do this knowingly or recklessly, then I understand that this renewal application may be refused, or if granted, subsequently revoked and that I may be prosecuted

E. I will transport animals in accordance with Council Regulation (EC) No. 1/2005 (the Regulation) on the protection of animals during transport once my Transporter Authorisation is renewed

F. I understand that it is an offence to transport any animals which require an Animal Transporter Authorisation, under the Regulation without current and valid authorisation issued by APHA

G. I will inform the office which issued the Authorisation of any changes in the details I have provided on this form **within 15 days** of those changes occurring and understand that if any information on the Authorisation Certificate changes, the Authorisation Certificate will be revoked and a new one will need to be issued

H. I have sufficient and appropriate staff, equipment and operational procedures to comply with the Regulation and that I will only entrust the animals transported in the course of my/our business to persons who have demonstrated their competence in accordance with the Regulation

I. I will ensure a copy of the Authorisation is carried in the vehicle(s) at all times when transporting animals and the Authorisation will be made available to any Enforcement Officer within the United Kingdom or European Union if asked to do so.
