RACECOURSE PASS CARD TERMS AND CONDITIONS

1. The PASS Card should be signed immediately upon receipt.
2. The PASS Card should be kept safe at all times. It is your access to racecourses.
3. The PASS Card remains the property of the RCA and must be surrendered on request. It is not transferable.
4. The PASS Card will give admission to Racecourses in line with current badging policy. This policy may be amended from time to time without notice.
5. Restrictions of the PASS Card are as currently advertised. Any changes will be published in the racing press and publications.
6. Supplementary identification may be asked for.
7. Corporate PASS Card holders must carry company identification or a letter of introduction along with the card in order to gain access.
8. If you use or attempt to use the PASS Card in any way other than that for which it is intended you will be liable for any consequences and it may be cancelled or suspended.
9. If the PASS Card is lost, stolen or damaged please notify the central Helpline/Faxline immediately.
10. Please also notify the central Helpline/Faxline if you change your name and address.
11. The RCA reserve the right to charge for replacement of lost, stolen or damaged cards.
12. Use of the PASS Card may be cancelled or suspended or the card may not be renewed. In any such event an explanation will be given
13. PASS Cards may be re-issued from time to time to take account of alterations to the system.
14. You should not disclose the PASS Card number to anyone other than the central Helpline/Faxline, Racecourses or PASS operators.
15. The PASS Card also gives privileges which may be amended from time to time without notice.
16. Unless you have notified us to the contrary, Personal Data may be used to notify you of other products / services which may be of interest to you.
17. Information about you will be held and processed for use with the PASS system. We will only disclose such information when compelled to do so by law and as required by the Data Protection Act 1984.
18. The RCA reserve the right to alter, amend, or add to these conditions at any time.
19. Entry to each Racecourse is subject to the Terms and Conditions of entry at that Racecourse.
20. PASS Cards are strictly non-transferable and abuse may result in your card being withdrawn.
